AN ORDINANCE ESTABLISHING THE POSITION OF PROBATIONARY LABORER / OPERATOR, FULL-TIME, FOR THE STREET DEPARTMENT, AMENDING SECTION I, ARTICLE 1 of ORDINANCE NUMBER 1113-99, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Poland, Mahoning County, Ohio desires to create a full-time position of Probationary Laborer / Operator for the Street Department; and

WHEREAS, it is the intent of the Council of the Village, Mahoning County, Ohio, to provide for the public peace, health and safety, by creating this position to replace a retiring full-time Street Department employee, and therefore an emergency arising.

NOW, THEREFORE, BE IT ORDAINED BY THE Council of the Village of Poland, Count of Mahoning, State of Ohio:

Section 1. That Section I, Article 1, of Ordinance 1113-99 be amended to include the following:

SECTION I, ARTICLE 1: HOURLY PAY RATES

- A) Pay rate established for one year for Probationary Laborer / Operator is \$15.00.
- B) Pay rate established at one year anniversary date for Probationary Laborer / Operator is \$15.75.
- C) Pay rate established at two year anniversary for Probationary Laborer / Operator will be full Street Department rate with probationary designation lifted.

Section 2. That a copy of this ordinance shall be entered into the official records of the Village of Poland, County of Ohio, State of Ohio.
